

## IN THE GENERAL ASSEMBLY STATE OF

## **Healthy Schools Act**

1	Be it enacted by the People of the State of, represented in the General
2	Assembly:
3	Section 1. Title. This act shall be known as and may be cited as the "Healthy Schools Act."
4	Section 2. Purposes. The Legislature hereby finds and declares that:
5	(a) The Legislature recognizes that good nutrition and regular physical activity affect the
6	health and well-being of students who attend public school in this state, and
7	(b) Research suggests that there is a positive correlation between a student's health and
8	well-being and his or her ability to learn, and
9	(c) Schools can play an important role in the developmental process by which students
10	establish their health and nutrition habits by providing nutritious meals and snacks
11	through school meal programs, by supporting the development of good eating habits,
12	and by promoting increased physical activity both in and out of school, and
13	(d) This effort to support students in developing healthy behaviors and habits with regard
14	to eating and physical activity cannot be accomplished by public schools alone, and
15	(e) It is necessary for school staff, parents, and the public at large to be involved in a
16	community-wide effort to promote, support, and model these healthy behaviors and
17	habits,

## 1 <u>Section 3</u>. <u>Requirements</u>.

2	(a) By (insert date), each school district shall submit to the Department of Education
3	(DOE) a copy of its school wellness policy as required by the Child Nutrition and
4	WIC Reauthorization Act of 2004 and a copy of its physical education policy
5	required under (insert relevant state statute if applicable). Each school district shall
6	annually review its school wellness policy and physical education policy and provide
7	a procedure for public input and revisions. In addition, each school district shall send
8	an updated copy of its wellness policy and physical education policy to the DOE
9	when a change or revision is made.
10	(b) Each school district shall promote its school wellness policy to faculty, staff, parents
11	and students. A copy shall be:
12	(1) Posted on each school's website, if it has one;
13	(2) Distributed to food service staff members
14	(3) Distributed to the school's parent/teacher organization, if it has one and
15	(4) Made available in each school's office.
16	(c) Each school district shall adopt the following wellness policies in an effort to enable
17	students to establish good health and nutrition habits:
18	(1) With regard to nutrition education, each school district shall:
19	a. Include nutrition education in the health curriculum that has
20	developmentally appropriate activities that are integrated throughout the
21	year. Instruction shall be sequential and standards-based and shall provide

1		students with the knowledge, attitudes, and skills necessary to lead healthy
2		lives.
3	b.	Extend nutrition education beyond the classroom by engaging and
4		involving the school's food service staff and by using the school cafeteria
5		as a "learning lab" that allows students to apply the knowledge, attitudes,
6		and skills taught in the classroom when making choices at mealtime.
7	с.	Extend nutrition education beyond the school by engaging and involving
8		the students' families and the community.
9	d.	Promote standards and benchmarks for nutrition education through a
10		variety of media.
11	e.	Inform all staff of and provide appropriate training to selected staff in the
12		best practices of nutrition education.
13	f.	Provide families with information to encourage and assist them in their
14		efforts to incorporate physical activity into their children's daily lives.
15	g.	Encourage the establishment of community and business partnerships that
16		institute programs supporting physical activity.
17	h.	Whenever possible, provide community residents with the opportunity to
18		utilize athletic facilities during non-school hours.
19	i.	The school district will assess, and if necessary and to the extent possible,
20		make needed improvements to make it safer and easier for students to
21		walk and bike to school. When appropriate, the district will work together
22		with local public works, public safety, and/or police departments in those

1	e	fforts. The school district will explore the availability of federal "safe
2	r	outes to school" funds, administered by the state department of
3	tı	ransportation, to finance such improvements. The school district will
4	e	ncourage students to use public transportation when available and
5	a	ppropriate for travel to school, and will work with the local transit agency
6	to	o provide transit passes for students.
7	(2) With re	egard to physical activity, each school district shall:
8	a. P	rovide a physical education curriculum that is aligned with the state
9	S	tandards, and that is sequentially planned in order to teach the
10	k	nowledge, skills, and attitudes necessary to live an active, healthy life.
11	b. F	For elementary schools, require a mandatory 15- to 30 minute recess that
12	с	onsists of physical activity on the days students do not have physical
13	e	ducation class.
14	c. F	For students in grades 6 through 12, offer opportunities for extracurricular
15	a	ctivities and intramural programs that emphasize physical activities.
16	d. F	For students in kindergarten through grade 12, provide a curriculum that
17	iı	ncludes moderate to vigorous daily physical activity beyond the school
18	d	ay.
19	e. P	Provide families with information to encourage and assist them in their
20	e	fforts to incorporate physical activity into their children's daily lives.
21	f. E	Encourage the establishment of community and business partnerships that
22		nstitute programs supporting physical activity.

1	(3) With	regard to other school-based activities, each school district shall:
2	a.	Assist each school in establishing a wellness committee to help coordinate
3		physical activity, nutrition, and other aspects of student and staff wellness.
4		The wellness committee may include parents, students, teachers, a school
5		nurse, physical education teachers, health teachers, or members of the
6		school administration.
7	b.	Communicate information to parents on nutrition and the benefits of
8		physical activity, and specific information concerning their children's
9		health.
10	с.	Assist schools in offering healthy food and beverage options at fundraising
11		activities and school-sponsored events and during field trips.
12	d.	Eliminate marketing and sale of all branded foods on school grounds.
13	e.	School districts shall explore methods to increase breakfast participation.
14	f.	School districts in which more than 50% of students are eligible for free or
15		reduced price school meals will explore methods to sponsor a summer
16		food service program for at least six weeks between the last day of the
17		academic school year and the first day of the following school year, and
18		preferably throughout the entire summer vacation.
19	(d) The DOE	shall designate the school district superintendent (or equivalent) as the
20	individual	charged with operational responsibility for measuring and evaluating the
21	school dist	trict's progress in implementing the policies specified in the school

1	(e) The school district superintendent shall appoint a district wellness committee that
2	consists of one or more representatives from the school board, the administration, the
3	food service department, the parents, the students, and the public. The district
4	wellness committee shall annually review the district's wellness and physical
5	education policies and provide the superintendent with any recommended changes to
6	the local wellness policy.
7	Section 4. Effective Date. This Act shall become effective immediately upon being enacted
8	into law.
9	Section 5. Severability. If any provision of this Act is held by a court to be invalid, such
10	invalidity shall not affect the remaining provisions of this Act, and to this end the provisions
11	of this Act are hereby declared severable.
